

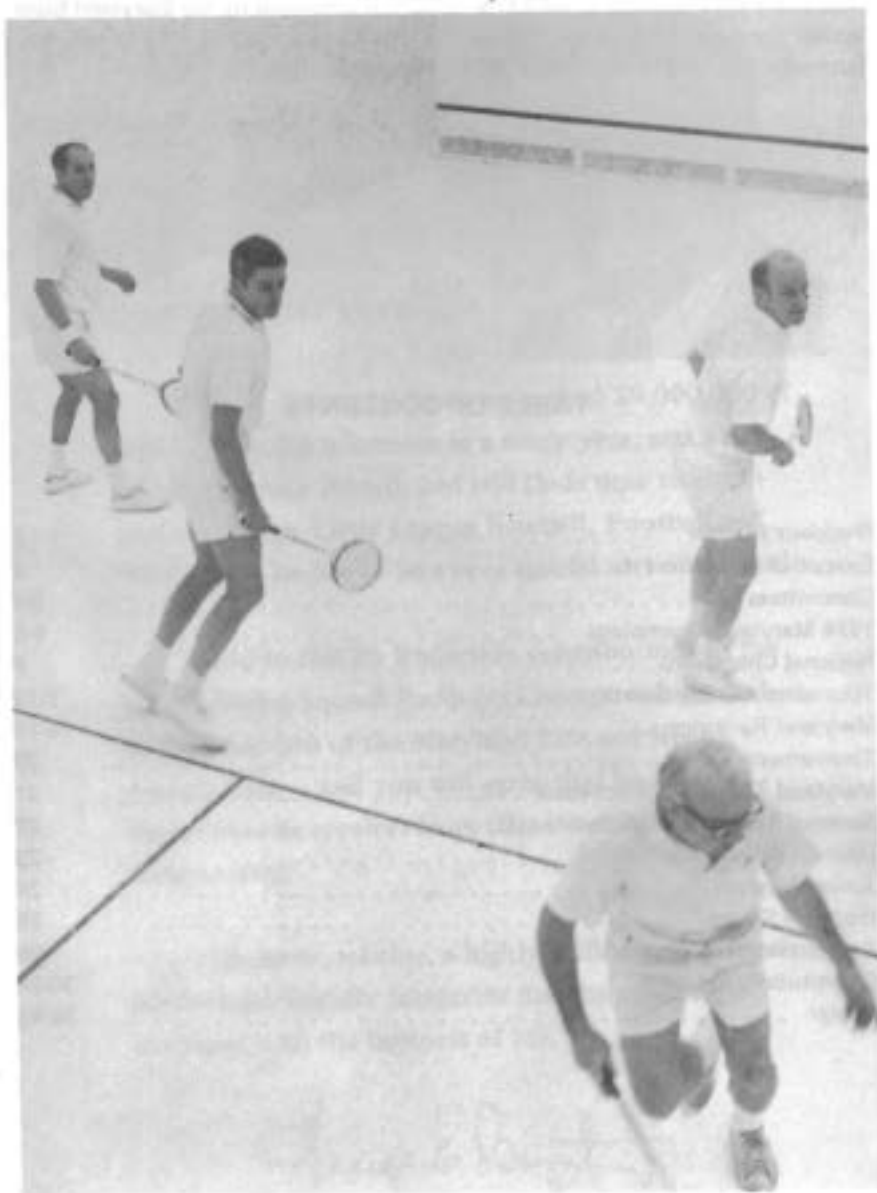

Dear Squasher:

When the B Doubles Tournament begins on October 24, the MSSRA will have officially launched what I trust will be one of its most exciting seasons. The new Executive Committee represents a cross-section of all players, the old guard, new members, A players to D players. We have been listening to all comments and criticisms, from all sources, with the purpose of making squash in Maryland a more enjoyable and rewarding experience.

Innovation comes this year primarily in our new tournament rules. With membership now having reached 220, an all-time high, and with more women and young people playing and enjoying squash, it becomes necessary to require a strict enforcement of the tournament rules. Each tournament will now have its own director, to keep play moving, to keep matches on schedule and, if necessary, to declare forfeits for those not complying with the rules. The new tournament rules are set forth, in full, in this publication. While tournament play should be fun, a lack of consideration for the other competitors is inexcusable. Play (on time) - enjoy squash.

Before heading into the 1974-75 season, let's look quickly and happily back to last year. The Nationals and the Baltimore Invitational came in rapid succession; each functioned smoothly thanks largely to the superb organizational abilities and personal efforts of Haswell Franklin and Joe Lacy. In addition the women players sponsored the National Women's Senior Doubles Tournament and the Junior Program produced an outstanding weekend with Hashim Kahn.

I am delighted and honored with the opportunity to head this Association. Your Executive Committee and I will welcome any constructive thoughts or suggestions directed toward making squash more enjoyable for all.

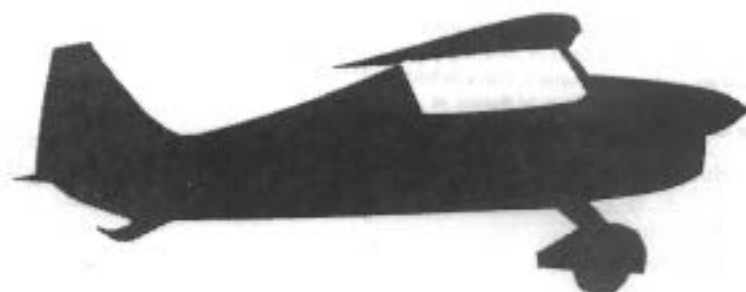

This possibility applies particularly if a player feels that age or inactivity have had an adverse effect on the caliber of his game on a fairly permanent basis.

If a player feels that he is "under-rated", he need not contact the Ranking Committee; it will undoubtedly be contacted by his opponents.

The Ranking Committee reserves the right to review any tournament entrant not ranked above to determine eligibility. The Ranking Committee consists of Bob Hogan, Joe Lacy, Butch McCleary, John Menton, Al Weaver, Mickey Webster, and Bob Hicks, chairman.

Since 1973 a new magazine devoted to squash has been published by Squash Racquets USA, P. O. Box 11051, Salt Lake City, Utah 84111.

Lowell M. Durham, Jr. is editor of this attractive quarterly magazine called, you guessed it, **Squash**. The publication reports on new trends in the game, provides instructional articles and keeps abreast of tournament news. A subscription is \$6 a year. It is the first magazine published in the United States devoted entirely to squash as far as we can determine.

TOURNAMENT RULES

The major change in tournament rules for the 1974-75 season is the designation of a director to run each tournament. This system replaces the traditional format which finds one person attempting to keep tabs on every tournament.

The second vice president of the MSSRA shall serve as chairman of the Tournament Committee and shall appoint a director who shall be responsible for running the particular tournament he or she has been assigned in accordance with the published tournament schedule.

All matches - with no exceptions - shall be played by the time specified on the draw sheet.

Sign-up sheets shall be posted two weeks prior to the start of a tournament. Draw sheets shall be posted three days prior to the start of a tournament. Sign-up and draw sheets shall be posted at the Baltimore Country Club, The Johns Hopkins University, the Maryland Club, the Racquet Club and the Towson YMCA.

No person may enter a tournament unless he is a paid member of the Maryland State Squash Racquets Association.

All matches will be played in the greater Baltimore area unless otherwise mutually agreed upon.

The top man in each individual pairing is responsible for the time and place of the match and also for meeting the draw sheet deadlines.

Winners of each match must report scores to the Tournament Director immediately following each match.

The official ball to be used will be listed on the draw sheet, but another ball may be used if mutually agreed upon.

The Tournament Director will referee the final match but there will be no referees for other rounds unless specifically requested and agreed upon by the Tournament Director.

Attire shall be white.

Subject to the above local rules, all matches shall be played in accordance with the rules of squash as promulgated by the United States Squash Racquets Association and published in its last annual yearbook.

Defaults will be strictly enforced for the violation of any of the above rules. So observe the rules, play your matches on time - and, most of all, enjoy yourself.

Women in the Maryland State Squash Racquets Association had a busy and productive squash year in 1973-74.

In December the second Baltimore Invitational Singles and Doubles Tournament, a nationally sanctioned event, was conducted. Ginny Akabane, of Rochester, repeating as the singles champion, defeating Goldie Edwards, of Pittsburgh, 3-1, in a well-played match. Judy Michael and Barbara Maltby of Philadelphia, downed Baltimore's Helen Lacy and Margaret Riehl, 3-0, for the doubles title. In the consolation singles

Our Maryland State Singles Tournament, held in January, attracted the largest field we've ever had. The matches were more exciting than in past years as the players continued to work hard improving their games. Dale Philippi defeated Marge Riehl, 3-0, in the finals.

In early February two teams of five women traveled to New Haven to represent Maryland in the Intercity Howe Cup Matches. Both our teams lost but each gained a great deal of experience.

The day after returning to Baltimore from the Howe Cup we hosted the Great Britain Combined Armed Services Team for three days. These women played at the Baltimore Country Club and Racquet Club. The ladies from the Towson YMCA also joined us.

In March the National Senior Singles and Doubles Tournament was held at the Racquet Club with the finals at the Baltimore Country Club. Goldie Edwards defeated Betty Howe Constable, of Princeton, in the singles finals, 3-0. Mrs. Constable teamed with Peggy Carrott, of Greenwich, to defeat Barbara Hunter and Louise Manley Power in the doubles finals, 3-1.

The Maryland State Doubles finals matched Nancy Miller and Mary Brooks against Helen Lacy and Margaret Riehl with Miller-Brooks winning, 3-1.

The Interclub Bowl was won again by the Racquet Club no. 1 team with Baltimore Country Club's no. 1 team a close second. Next year we anticipate another tight race. Mary Brooks ran the Interclub competition.

Helen Lacy, Margaret Riehl and Mary Brooks traveled out of town to several tournaments in 1973-74 to gain more squash experience. In addition Helen Lacy and Margaret Riehl are representing the Maryland State Squash Racquets Association on the USWSRA National Board.

Tom Schweizer's 30 years of service to Maryland squash have been so varied that a little imagination could produce this scene: the day he won the State singles title in 1955 he also refereed the match, brought the trophies, engraved and presented them, called in the results to the newspapers, mopped the court, mixed post-match drinks and made sure the showers were working.

Of course this episode is fantasy. But TS I, as he is called, has done it all in Maryland squash, both on and off the court.

The only State championship to elude him has been the A Doubles. He won the singles in 1955, the B Doubles in 1966 with Zandy Harvey, the Senior Doubles in 1972 with Jim Lacy and in 1973 with Dan Senft, the Baltimore Club Invitational Doubles with Bill Lamble in 1968 and 1969, the Maryland Club singles in 1958 and 1961, the Maryland Club Doubles in 1966 with Joe Lacy and the Maryland Club Invitation Championship singles in 1961. He has also played in all of the 26 annual Fitzgerald Cup matches with Washington, D.C., an honor he shares with Bill Lamble.

In the past two years, Tommy has enjoyed great success on the Senior Doubles circuit, winning the Canadian National Seniors in 1973 and 1974 with Ed Hahn and capturing the Tom Byrne Seniors with Jim Lacy in 1972, 1973 and 1974. He and Jim were top-ranked in the country in Veterans Doubles last year.

But, as his frequent playing companion Jim Lacy says "Tommy does as much for squash off the court as on it."

His contributions to the game in Maryland go far beyond his role as treasurer for the past 20 odd years. "No job is too small for Tommy," Jim Lacy adds. "When no one else can find time to collect the championship bowls, he'll make time and do it. I could think of hundreds of examples like this."

As the MSSRA grows, and responsibility is shouldered by more individuals, Tommy's role is still vital. His office at the Village of Cross Keys is the central focus of the Association as it has been for many, many years.

One of Maryland's outstanding sportsman, Tommy would be the first to admit he has reaped untold rewards from squash. But no one would argue with the contention that he has put back even more than he has gained.

MSSRA CONSTITUTION AND BY LAWS

ARTICLE I TITLE AND PRINCIPAL OFFICE

The Title of this Association shall be the "Maryland State Squash Racquets Association". The principal office of the Association shall be in Baltimore, Md.

ARTICLE II OBJECT

The purpose of this Association shall be to promote the game of squash racquets in the Maryland area, to protect the mutual interests of the members of the Association, and to establish and enforce uniformity in the rules of the game.

ARTICLE III UNINCORPORATED ASSOCIATION

The Association shall be an unincorporated Association in accordance with the laws of the State of Maryland. The Association is not organized and shall not be conducted for pecuniary profit and no part of its funds, however acquired, shall inure to the benefit of any officer, member or individual, except that the Association may pay consideration for work, labor or materials furnished to it.

In addition to the powers specifically conferred upon it by law, the Association shall have the power to receive gifts, devices and bequests of money or property of whatsoever kind or description; to acquire, hold, sell, give or otherwise dispose of such real and personal property as the purposes of the Association may require; and generally to do any and all other acts and things incident to and in furtherance of the aforesaid purposes of the Association not forbidden by law or by the by-laws of the Association.

ARTICLE IV MEMBERSHIP

Section 1. Types of membership. Membership shall consist of MILITARY AND COLLEGIATE ORGANIZATIONAL and INDIVIDUAL MEMBERS.

SECTION 2. MILITARY shall consist of those individuals who are members of the military service and who are stationed at a military establishment within the State of Maryland, or who are attending a military school within the State of Maryland. Annual dues will be established by the Executive Committee.

COLLEGIATE shall consist of those individuals who are bona fide students of any school, college or university within the State of Maryland. Annual dues will be established by the Executive Committee.

SECTION 3. ORGANIZATIONAL MEMBERS shall consist of those clubs and associations located in Maryland, and which have been duly elected to membership by the Executive Committee. Dues and fees for the member clubs shall be set by the Executive Committee.

SECTION 4. INDIVIDUAL MEMBERS shall be players or friends of squash who are residents of the State of Maryland and who pay annual dues to the Association in an amount established by the Executive Committee at the annual meeting. They shall be members of an organizational club or should be invited to join by Executive Committee. Individual members shall be (1) Entitled to participate in tournaments sponsored by the Association and (2) to receive a copy of the Association yearbook without charge and (3) to vote at any general membership meeting.

ARTICLE V EXECUTIVE COMMITTEE

Section 1. Powers - The Executive Committee shall be entrusted with the management of the Association. It shall be its duty to carry out the purposes of the Association according to the by-laws, and shall be the final authority in all matters concerning policy, administration and management of the Association.

Section 2. Corporation - The Executive Committee shall consist of the following members:

- A. One designated representative from each member organization.
- B. The duly elected officers of the Association.
- C. The representative or representatives to the USSRA appointed by the President to represent the Association.
- D. The immediate two Past Presidents.
- E. The chairman of all committees designated in these by-laws.
- F. Any additional member(s) as designated by the President.

A majority of the members of the Executive Committee shall constitute a quorum.

ARTICLE VI OFFICERS

Section 1. OFFICERS - The officers of this Association shall consist of a President, a First Vice President, a Second Vice President, a Secretary, a Treasurer, and an Historian.

Section 2. Election and Term of Office - The officers shall be elected by a majority vote at the Annual Meeting of (The Organizational Clubs) the Association for a period of two years. In the event of absence or disability of any officer of the Association for a prolonged period of time, the Executive Committee may fill such vacancy during such absence, or for the remainder of his or her term of office.

ARTICLE VII DUTIES OF OFFICERS

a. President and Vice-President: The President, and in his absence the First Vice-President, shall preside at all meetings of the Association and Executive Committee, and if neither shall be present, the Second Vice-President, the Secretary or Treasurer, respectively, shall preside. The President shall appoint all committees not otherwise herein provided for; appoint the representative or representatives to the National Association (U.S.S.R.A.); and oversee the performance of respective duties of other officers, committees and representatives. In the event of absence or disability of the President, the Vice President shall possess and exercise all the powers of the President.

b. Vice President and Second Vice President: In addition to the duties outlined in "a" above, the First Vice President shall serve as Chairman of the Ranking Committee, and Chairman of the Invitational Doubles Tournament, or be responsible for the appointment of the chairman, whose appointment must be approved by the Executive Committee.

The second Vice President shall serve as Chairman of the Tournament Committee.

c. Secretary: The Secretary shall conduct the correspondence and keep the records of the Association and its Executive Committee, shall issue calls for such meetings and shall perform such other duties as the Executive Committee may from time to time require. He shall also serve as Chairman of the Inter-Club Squash League.

d. Treasurer: The Treasurer shall collect the dues and other revenue of the Association, pay all authorized bills, keep the accounts of the organization, submit a report of the financial condition of the Association at the first annual meeting of the Executive Committee and a proposed budget for the ensuing year. He shall serve as chairman of the Scheduling Committee.

The Treasurer shall also purchase prizes for competitions sponsored by the Association and have them suitably engraved. He shall perform such other duties as the Executive Committee may from time to time require.

e. Historian: The Historian shall maintain records of winners and runners-up of all tournaments, shall maintain a file of all suitable photographs and clippings. He shall research all previous tournaments in order to maintain accurate historical records. He shall keep a record of the donors of all trophies. He shall research previous records in order to maintain a record of previous presidents of the Association. He shall be in charge of publicity and publications. He shall be responsible for the publication of the annual yearbook. He shall perform such other duties as the Executive Committee may from time to time require.

ARTICLE VIII MEMBERSHIP DUES

a. Organization: Each member organization shall pay the Treasurer each playing season annual dues for membership entitling them to participate in interclub play with one team, singles or doubles.

b. Individual:

1. Active - any individual member who wishes to compete on a team for an organization or in tournament play, to be officially ranked and who wishes to participate in all other Association activities and benefits.

2. Contributing - Those members who wish to be entitled to all the benefits of the Association and as a friend of the Association and the game of squash racquets in the Maryland area contribute to and sponsor the Association's activities.

c. The amount of the annual dues and additional fees shall be set by the Executive Committee at the first annual meeting and such dues and fees are payable upon receipt of the bill from the Treasurer.

ARTICLE IX MEETINGS

a. The annual meeting of the Association shall be held on the last Wednesday in March of each year.

b. Special meetings and meetings of the Executive Committee may be called by the President at any time upon seven days notice.

ARTICLE X COMMITTEES AND REPRESENTATIVES

- a. **Ranking Committee:** This committee shall consist of at least 3 members; the Chairman shall be the First President of the Association.
- The ranking shall be furnished to the Secretary and Historian of the Association prior to 1st June of each year.
- b. **Scheduling Committee:** The committee shall consist of at least 2 members. The chairman shall be the Treasurer of the Association.
- The Schedule, including the locations of each tournament, shall be furnished to the Secretary and Historian prior to 1st June of each year.
- c. **Publicity Committee:** This committee shall be chaired by the Historian of the Association and such other members as he may appoint and shall effectuate adequate publicity of all activities of the Association.
- d. **Tournament Committee:** This committee shall be chaired by the Second Vice President of the Association and such other members as he may appoint. It shall be the duty of the committee to make the draw and preparations for all tournaments of the Association. This committee shall have authority on matters concerning eligibility, defaults, scheduling of matches, time of play, and collection of entry fees as shall be determined by the Executive Committee.
- e. **Referees Committee:** This committee shall be appointed by the President of the Association. It shall be the duty of this committee to provide referees for all tournaments.
- f. **Nominating Committee:** This committee shall consist of three individual members of the Association, each of whom shall represent a different organization. The Chairman shall be the immediate past president of the organization. It shall be their duty to nominate officers for the coming season. The report of this committee shall be submitted in writing to the President and Secretary three weeks prior to the March meeting, at which time officers shall be elected.
- g. **Representative to the U.S.S.R.A.:** The representative(s) to the U.S. Squash Racquets Association shall attend, on behalf of the Association, meetings of the U.S. Squash Racquets Association and shall represent the Association on all matters at such meetings. He shall be appointed at the annual meeting by the President with the approval of a majority of the Executive Committee.
- h. **Special Events Committee:** Shall consist of a Chairman and such other members as he may appoint. This committee shall organize, and supervise any and all "special" activities not connected with tournament or interclub play, i.e. visiting teams, exhibition matches, and any other activity which the Association may undertake.
- i. **Other Committees:**
1. Membership
 2. Annual Dinner
 3. Fitzgerald Cup
 4. National Team
 5. Ladies Committees

- j. In addition to the foregoing standing committees, the President shall at any time appoint such other committees as may be necessary for the proper functioning of the Association.

ARTICLE XI AMENDMENTS TO CONSTITUTION AND BY-LAWS

The Constitution and By-Laws may be amended at any meeting of the Executive Committee by the vote of two-thirds of all the members of the committee. Proposed amendments must be presented to the Secretary at least two weeks before any meeting and a copy of such amendments must be mailed by the Secretary to all members of the committee at least five days prior to said meeting.

- a. This Association shall abide by all rules of the United States Squash Racquets Association.
