





The good news was the "Y" won the Interleague "C" Championship while the bad news was the squash court lighting is still less than optimum. We had twelve participants in the Insilco tournament with Ralph Bulle being the eventual winner. The tournament was helpful in introducing players to each other. Both Bob Noll and Gerd Petrich played in the Boodles/Washington D.C. Jamboree in April, 1980.



#### MSSRA Season Highlights

#### State Singles Championships by Jim McCaslin

The 1980-81 MSSRA State Singles Championships were held over the weekend of January 30-February 1, 1981, in Baltimore, Maryland. There were seventeen players in the "A" draw, twelve in the "B", twentythree in the "C", and twenty-five in the "D" draw. Competition was held in most of the major squash clubs in the greater Baltimore area with all semifinal and final matches played at the Baltimore Country Club. This year's competition offered two additional features: (1) consolation rounds for first round losers; and (2) playoffs for the third and fourth spots in the championship rounds.

In the "A" draw, Sandy Martin, sporting his number three national doubles ranking, was the number one seed. Dr. John Minkowski was ranked second, Dr. Steve Rosenblum third, and Dr. Peter Wilson fourth. Martin, after recently winning the Baltimore City Open, defeated fellow Maryland Clubbers Barrett Freedlander (3-0) and Bill Rice (3-0) before he encountered Rosenblum, three-time MSSRA State Champion, in the semifinals. His match was a hard-fought battle with the scrappy, wily veteran and was won in overtime in the fourth on a let-point called by referee Jim Hense. Martin displayed outstanding racquet skills, deft shot-making, good power, and excellent gamesmanship in defeating Peter Wilson in the finals (3-0).

Wilson upset the number two seed, John Minkowski, in the semi-finals (3-1). Scott Jordan defeated Peter Wolff (3-2) to win the consolation round.

The "B" singles draw was perhaps the best in recent years. The entries were mixed with seasoned veterans and out-of-town ringers, as well as young upstarts. Charles Fenwick, who had recently lost in the Insilco B/C Regional Finals, was number one seed. The number two seed was Arv Gilette, a recent transplant from the New York "B" league. The number three seed was Richard Thomas and the number four seed was Dave Warfield.

Youth prevailed as Dave Warfield defeated Ray Blank (3-1), John Clarke, Jr., product of the Maryland Junior program, (3-1), and Arv Gilette (3-1) to win the "B" crown.

As far as our MSSRA records go back, Warfield is the only person to win the "D", "C", as well as the "B" event. In the play-offs for the third and fourth positions, John Clarke defeated Richard Thomas.

The "C" singles draw was significantly less in the quantity of entries but the quality of play was exceptional. Number one seed was Bob Travers. The number two seed, Richard Moxon; number three seed, John Voneiff; and number four seed, Bill Bruchey. John Voneiff upset the number one seed, Bob Travers (3-2) in the semi-finals and met Dave Barclay in the finals. Dave Barclay eluded the handicappers and displayed considerable skill in the tournament play until he was defeated by John Voneiff (3-1) in the finals. (Sukon) Kancharanaraska won the consolation event without playing a single match!

The "D" singles draw was also lighter than expected with only twentyfive players entered. None of the seeded players, number one, Don Townsend; number two Peter Gerard; number three, lim Smith; number four, Gary Zipper, reached the finals. Bruce Preston prevailed through six matches, losing only two games, to win the "D" title over Bill Berault (3-0). Dave McDonnell defeated lim-Evring (3-1) in the finals of the "D" consolation bracket. Don Townsend, Ir., another product of our junior program, won the play-off for the third spot by defeating Kerry Tenberg (3-1).

Earlier in the year, Gene O'Conor won the Maryland State Veterans Singles Championship.

#### State Doubles Championships by Jim McCaslin

The 1980-81 Maryland State Squash Racquets Association State Doubles Championship season is completed. There were five separate championships, including A, B, C, Veterans, and Seniors events. The age group competition was hosted by the Maryland Club and the other championship events were played at the Baltimore County Club, as well as the Maryland Club.

Sandy Martin, our nationally ranked doubles player, was the Tournament Director, but, for the first time in many years, he did not compete in the action. The number one seeded team was Joe Lacy and John Mac-Coll and second seeded team was John Menton and Bill Rice. The competition began Friday, February 20 with 16 teams and concluded Sunday with semifinals and finals being played at the Baltimore Country Club. In the semifinals, the number one seeded team, loe Lacy and John MacColl handily defeated Bob Hogan and Iim McCaslin (3-0). The newlyformed Veterans team of Peter Wolff and Ted Berger were defeated by the number two seeded John Menton and Bill Rice (3-2). Finals were somewhat unspectacular, but Lacy and MacColl prevailed over Menton and Rice (3-0).

Over the same weekend, thirteen C Doubles teams competed for the C crown. Number one seeds were Gordon Priest and Rick Hook and the number two seeds were Digger Krebs and Tommy Biddison. The number one seeded team of Priest and Hook were upset in the quarterfinals by Bill Bruchev and Bob Everd of the Deitz Racquet Club. Bruchey and Everd continued their winning ways by defeating Allan Acton and Peter Rose at the Towson Center. In the bottom half of the draw, Digger Krebs and Tommy Biddison muscled their way past Joyce Hogan and Mary McGuirk. In the finals, which were held at the Baltimore Country Club, Krebs and Biddison turned back the upset-minded team from Harford County to claim the C Championship.

Over the weekend of February 27-March 1, thirteen B Doubles teams competed for the B Championship. The number one seeded team and perennial runners-up for the B crown. Jim Tillman and Paul Deitz were upset in the semifinals by the young team of Dave Warfield and Richard Thomas. In the other half of the draw, the wily veteran team of Iervis Finney and Tommy Greene upset Bob Hogan and Jim McCaslin to create an all Maryland Club final. Youth just barely prevailed, as the team of Dave Warfield and Richard Thomas squeaked past Finney and Greene (3-2) to claim the B crown.



During the week of March 2, nine veteran teams competed for the Veterans Doubles Championship. The Tournament Director, Jack Fetting, seeded Joe Lacy and Bob Voelkel number one and Jervis Finney and Tommy Greene number two. In the semifinals Lacy and Voelkel turned back Ted Berger and Peter Wolff (3-0). In the other half of the draw, Finney and Greene were upset by the newly formed team of A. C. Hubbard and Bob Hogan (3-1). In the finals, the hot new team of Hubbard and Hogan continued their winning ways by handily defeating Lacy and Voelkel (3-0) to claim the Veterans Crown.

During the week of March 13 (and then some), seven Seniors teams competed for the Seniors Doubles Championship. The tournament Director, Dick Catzen, seeded lack Fetting and Fred Smith number one and Tommy Schweizer and Jack Bandiere, number two. At the top half of the draw, Gene O'Conor and John Riehl squeaked past lack Fetting and Fred Smith (3-2). In the bottom half of the draw, Dan Senft and Freddy Williams defeated Tommy Schweizer and Jack Bandiere. In the finals, which were held at the Maryland Club, Dan Senft and Bob Williams defeated Gene O'Conor and John Riehl (3-0) for the Seniors Title.

#### State Women's Championship by Greg Szoka

The 1981 Maryland State Women's Squash Racquets Championship marked a return to the mid-week tournament format. This, coupled with the liberalization of women's eligibility requirements for men's tournaments, produced a small, but strong, draw, including defending champion, Mary McGuirk; former champion, Helen Lacy; and the wily veteran, Nancy Taylor.

The first round matches saw new-

comer Margie Goldsborough best Helen Lacy in a gruelling 5 game match, while the other first round participant, Toby Gordon, walked to the semi-finals on a bye.

In the semi-finals, experience and court savvy proved to be the formula for success for McGuirk and Taylor. The lithesome McGuirk, using the drop-shot and lob to her best advantage, defeated Goldsborough, 3-0. In the other half of the draw, Taylor combined crisp rails with a devastating forehand to overpower Gordon in three.

The finals, which were held at the Marylea Farm Court, proved to be the most exciting match of the tournament. It was a showcase for the talents of these two fine squash players. Characterized by long rallies, the flow of the match constantly shifted. In the end, however, the advantage shifted to Taylor and McGuirk bowed 3-1.

In winning, Taylor joins the ranks of other women who have distinguished themselves by capturing the Maryland State Crown.

#### Men's National Doubles Championships

Second-seeded teams, proving that they try harder, succeeded in winning three of the four National Doubles titles which were decided in Baltimore March 27th through March 29th.

The 1981 U.S. National Doubles crown belongs to Vic Harding and Peter Hall from Toronto. In the finals, held at the Baltimore Country Club, they defeated Larry Heath and John Reese from New York, the top seeds, in three close games.

In each game, Harding and Hall, who won this title in 1977 and were seeded second this year, built a lead that was too substantial to overcome.

One semifinal matchup pitted Harding and Hall against Scott Ryan from Philadelphia and Jay Umans from New York. The other semifinal, featuring Heath and Reese against Tom Poor from Boston and Sandy Martin from Baltimore, was not decided until overtime in the fifth game. Poor and Martin won the first and third games 15/12, 15/9, respectively. The second and fourth games were taken by Heath and Reese by 15/8, 15/6 scores.

In the deciding game, it appeared that Poor and Martin, who were seeded third in this tournament, would upset the top seeds, as they held a 13/10 lead. Heath and Reese, however, tied the game at 13 to force extra points and won the opportunity to play in the finals by an 18/15 score.

#### Women's National Doubles Championships

For the first time, the Women's National Doubles were held in conjunction with the Men's Nationals. Carol Thesieres and Joyce Davenport of Philadelphia won the Women's title for the third straight year.

A total of eight women's teams participated in two divisions, with the winner of each division playing off for the title. In the finals, Thesieres and Davenport faced fellow-Philadelphians Gail Ramsey and Connie Pierce.

#### National Veterans Doubles Championships

Fitzgerald Cup by Haswell M. Franklin, Captain



Special thanks to Nancy Taylor and Bob Everd for their organizational skills and tireless effort.







#### Southey F. Miles Award by Dic Cotzen

The Baltimore Invitational Doubles and Singles Tournament has been attracting top squash players to the area every spring since it was begun by the University Club of Baltimore in the 30's. As was the case at most squash competitions in those early years, Philadelphia teams invariably walked off with top awards at the final ceremonies. But Philadelphia squashers were becoming famous for another "award" given in honor of the late Carter B. Simonin.

Carter B. Simonin loved squash tourneys, as did any other loyal Philadelphian, but unfortunately he seldom saw one because he participated so vigorously in the accompanying festivities; he was too "relaxed" to make his way to the gallery.

The "Carter B Simonin" award was established after his death in recognition of the tireless pursuit of the enjoyment of squash and was thenceforth presented to that individual who most exemplified Carter's championship performance off-court.

Baltimoreans soon recognized that behavior at their local Invitational equalled or surpassed any wayward deportment Philadelphia could muster. It was decided to initiate the Baltimore Chapter of the Simonin Award to be bestowed upon those squash afficiandos who, by dint of Herculean deeds in bad manners or inebriation, were judged to have sunk to standards high enough to qualify.

From the 40's until the early 70's, Southey F. Miles so dominated this aspect of the Baltimore Invitational that, upon his death, it was agreed that the Simonin Award, Baltimore Chapter, should forthwith be known as the "Southey B. Miles Award." The tribute is in recognition of Southey's determination to live life to its fullest.

The list of winners of this most prestigious award reads like a combination of "Who's Who" in Baltimore society and drunk tank regulars. Names of distinguished pastwinners are omitted here to protect the guilty!

Occasionally, even members of the Baltimore squash group do not live up to the high standards of bad deportment Southey would have approved and, consequently, no presentation of the award is made in those years.

To be judged a winner of the Southey B. Miles award, one must reach the pinnacle of perfection to which Southey aspired. It may be the finest hour of squash player's career; unhappily, however, it usually comes with one hell of a hangover!

Tournament Director's Duties and Responsibilities

Generally, the Second Vice President shall serve as the Chairman of the Tournament Committee. 

#### How To Prepare A Draw

Seeding

One person can be seeded for every four players entered in the tournament. It is not necessary to seed the maximum. The basis of seeding should be the current rankings and up-to-date playing results which can be obtained from the USSRA Office upon request. The positioning of the seeds in the draw is as follows:

#### In a 32 draw:

Seed #1 is placed on the top line (line 1).

Seed #2 is placed on the bottom line (line 32).

Seeds #3 and #4 are placed in the center (lines 16 and 17) as determined by the toss of a coin.

Seeds #5, #6, #7, and #8 are placed on the top lines of the second and fourth quarters (lines 8 and 9) and on the bottom lines of the first and third quarters (lines 24 and 25). Places are determined by the toss of a coin. However, seeds #5 and #6 must end up in opposite halves of the draw as must seeds #7 and #8. Placing (Optional)

For every seeded player, a player may be placed on the opposite side of the section from the seed. It is not necessary to place the maximum. Placing can be used when a tournament director feels that there is a distinct group of players, after the seeds, that warrant positioning advantage. The group of players should first be determined and then randomly placed.

#### Qualifiers

If there are more entrants than places in the draw (a draw usually being 16 or 32 or a power of 2), qualifying rounds may be held to pare down the field to the necessary number. For example, if there are 18 players entered in a 16 draw, then the two extra entrants will require two qualifying matches of two players each—or four players. The winner of each match enters the main draw.

It is also possible to hold open a number of places in the main draw for qualifiers and to arrange a competitive format for such places. In this case, any number of qualifiers may compete for the openings. For example, if there are two places held open in the main draw and eight applicants, two mini-tournaments of four each can be held to reduce the qualifiers to two winners who will be placed in the open places in the main draw.



#### Byes

If there are fewer entrants than places in the main draw, then first round byes are given. In a draw of 32 with only 28 entrants, there will be four byes. The byes go first to the seeded players in order of seeding. Any additional byes are placed working from the outside towards the center of the draw and alternating to and bottom halves—lines 4, 29, 6, 27, 12, 21, and 14 respectively.

#### Making the Draw

Place the #1 and #2 seeds. Toss a coin for placement of the #3 and #4 seeds. Toss a coin for placement of #5, #6, #7 and #8 seeds. Keep in mind that the #5 and #6 seeds as well as the #7 and #8 seeds must end up in opposite halves of the draw. The balance of the entries, including any qualifiers, are drawn randomly and placed. If the names of the qualifiers are unknown at the time of the draw, identify them as "qualifier A", "Oualifier B", etc.

The sample draw is for 32 entrants. For a 16 draw, seed only 4 players, place accordingly, and proceed with the draw, qualifying rounds or byes using the same principle as for the 32 draw. For a 64 draw, 16 players may be seeded and placed along the same principles.

#### MSSRA By-Laws

#### MARYLAND STATE SQUASH RACQUETS ASSOCIATION CONSTITUTION AND BY LAWS (as amended May 13, 1981)

ARTICLE I TITLE AND PRINCIPAL OFFICE

The Title of this Association shall be the "Maryland State Squash Recquets Association."

The principal office of the Association shall be in metropolitan Baltimore, Maryland.

#### ARTICLE II OBJECT

The purpose of this Association shall be to promote the game of squash racquets in the Maryland area, to protect the mutual interests of the members of the Association, and to establish and enforce uniformity in the rules of the game.

#### ARTICLE III POWERS

The Association shall be an unincorporated Association in accordance with the laws of the State of Maryland. The Association is not organized, and shall not be conducted, for pecuniary profit, and no part of its funds, however acquired, shall inure to the benefit of any officer, member, or individual, except that the Association may pay consideration for work, labor, or materials furnished to it. In addition to the powers specifically conferred upon it by law, the Association shall have the power to receive gifts, devises, and bequests of money or property of whatsoever kind or description; to acquire, hold, sell, give, or otherwise dispose of such real and personal property as the purposes of the Association may require; and generally to do any and all other acts and things incident to and in furtherance of the aforesaid purposes of the Association not forbidden by law or by the by-laws of the Association. The Association shall abide by all rules of the United States Squash Racquets Association.

#### ARTICLE IV MEMBERSHIP

Membership shall consist of the following types:

- a. Military shall consist of those individuals who are members of the military service and who are stationed at a military establishment within the State of Maryland, or who are attending a military school within the State of Maryland. Annual dues will be established by the Executive Committee.
- Collegiate shall consist of those individuals who are bona fide students of any school, college, or university within the State of Maryland. Annual dues will be established by the Executive Committee.
- c. Organizational shall consist of those clubs and associations located in Maryland, and which have been duly elected to membership by the Executive Committee. Dues and fees for the member clubs shall be set by the Executive Committee.
- d. Individual shall be players or friends of squash who pay annual dues to the Association in an amount established by the Executive Committee. They shall be members of an organizational club or should be encouraged to join by the Executive Committee. Individual members shall be entitled (1) to participate in tournaments sponsored by the Association, (2) to receive a copy of the Association yearbook without charge, and (3) to vote at any general membership meeting.

#### ARTICLE V EXECUTIVE COMMITTEE

a. Powers: The Executive Committee shall be entrusted with the management of the Association. Its duty shall be to carry out the purposes of the Association according to the by-laws, and it shall be the final authority in all matters concerning policy, administration, and management of the Association. It shall also be empowered to assign responsibility among the membership of the Association for the committees provided in Article X.

b. Members: The Executive Committee shall consist of the following members, a majority of which shall constitute a quorum: (1) the duly elected officers of the Association; (2) the two immediate past Presidents of the Association; and (3) the representative(s) to the USSRA.

#### ARTICLE VI OFFICERS

a. Officers: The officers of this Association shall consist of a President, a First Vice President, a Second Vice President, a Secretary, a Treasurer, and an Historian.

 Election and Term: The officers shall be elected by a majority vote at the annual meeting of the Association for a term of two years.

c. Disability: In the event of absence or disability of any officer of the Association for a prolonged period of time, the Executive Committee may fill such vacancy during such absence, or for the remainder of his or her term of office.

#### ARTICLE VII DUTIES OF OFFICERS

a. President and Vice-Presidents: The President, and in his absence the First Vice-President, shall preside at all meetings of the Association and Executive Committee, and if neither shall be present, the Second Vice-President, the Secretary, or Treasurer, respectively, shall preside. The President shall appoint all committees not otherwise herein provided for; appoint the representative or representatives to the USSRA; and oversee the performance of the respective duties of other officers, committees, and representatives. In the event of absence or disability of the President, the First Vice President shall possess and exercise all the powers of the President.

b. Secretary: The Secretary shall conduct the correspondence and keep the records of the Association and its Executive Committee, shall issue calls for such meetings, and shall perform such other duties as the Executive Committee may from time to time assign.

c. Treasurer: The Treasurer shall collect the dues and other revenue of the Association, pay all authorized bills, keep the accounts, submit a report of the financial condition of the Association at the first annual meeting of the Executive Committee and a proposed budget for the ensuing year. He shall perform such other duties as the Executive Committee may from time to time assign.

d. Historian: The Historian shall maintain records of winners and runners-up of all tournaments, and shall maintain a file of all suitable photographs and clippings. He shall research all previous tournaments in order to maintain accurate historical records. He shall keep a record of the donors of all trophies. He shall research previous records in order to maintain a record of previous presidents of the Association. He shall serve as chairman of the Communications Committee. He shall perform such other duties as the Executive Committee may from time to time assign.

#### ARTICLE VIII MEMBERSHIP DUES

- a. Organizational: Each member organization shall pay the Treasurer each playing season annual dues for membership entitling it to participate in interclub play with one team, singles or doubles.
- Active: Any individual member who wishes to compete on a team for an organization, to compete in individual tournament play, to be officially ranked, and to participate in all other Association activities and benefits.
- c. Contributing: Those members who wish to be entitled to all the benefits of the Association as a friend of the Association and the game of squash racquets in the Maryland area by contributing to and sponsoring the Association's activities.
- d. Amount: The amount of the annual dues and additional fees shall be set by the Executive Committee at the first annual meeting, and such dues and fees are payable upon receipt of the invoice from the Treasurer.

#### ARTICLE IX MEETINGS

- a. Annual Meeting of the Association shall be held on the last Wednesday in March of each year.
- b. Special Meetings and meetings of the Executive Committee may be called by the President at any time upon seven days' notice.

#### ARTICLE X COMMITTEES AND REPRESENTATIVES

- a. Ranking Committee: This committee shall consist of a chairman and at least two other members, all of whom shall be appointed by the Executive Committee. The rankings shall be furnished by the committee to the Secretary and Historian of the Association prior to June 1 of each year.
- b. Tournament Committee: This committee shall consist of a chairman and such other members as shall be appointed by the Executive Committee. It shall be the duty of the committee to make the draw and preparations for all tournaments of the Association. This committee shall have authority on matters concerning eligibility, defaults, scheduling of matches, time of play, and collection of entry fees. The annual agenda of matches and locations of play shall be furnished by the committee to the Secretary and Historian prior to June 1 of each year.
- c. Referees Committee: This committee shall consist of a chairman and such other members as shall be appointed by the Executive Committee. It shall be the duty of the committee to provide referees for all tournaments.
- d. Nominating Committee: This committee shall consist of a chairman and such other members as shall be appointed by the Executive Commmittee. It shall be the duty of the committee to nominate officers for the coming term. The report of this committee shall be submitted in writing to the President and Secretary three weeks prior to the annual meeting preceding the commencement of the term, at which meeting officers shall be elected.
- e. Representative to the USSRA: The representative[s] to the United States Squash Racquets Association shall be appointed by the Executive Committee. He or they shall attend, on behalf of the Association, meetings of the USSRA and shall represent the Association on all matters at such meetings.
- f. Communications Committee: This committee shall consist of the Historian, as chairman, and such other members as shall be appointed by the Executive Committee. It shall be responsible for publication of the yearbook and the newsletter, posting of notices of Association activities at

member organizations, liaison with "Squash News," and coordination with the general news media so as to effectuate adequate publicity of all Association activities.

g. Special Committees: The Executive Committee may appoint chairmen and other members so as to create from time to time such other committees as may be necessary for the proper functioning of the Association, including, but not limited to, those responsible for inter-club competition, annual dinner, awards, and the Baltimore Invitational Doubles and Singles, Insilco, Fitzgerald Cup, and Stevens Cup tournaments.

#### ARTICLE XI AMENDMENTS

The Constitution and By-laws may be amended at any meeting of the Executive Committee by the vote of two-thirds of all the members of the committee. Proposed amendments must be presented to the Secretary at least two weeks before any meeting, and a copy of such amendments must be mailed by the Secretary to all members of the committee at least five days prior to said meeting.
